READ BEFORE SENDING:

- 1. Regular and Associate Memberships are granted to individuals on an annual basis from January 1 through December 31. The membership of a person joining from October 1 through December 31 shall run until the end of the following year.
- 2. For any Regular Member, a second Regular Membership for one other member in the household is available at a discount. The additional family member must live at the same residence and be over 18 years of age. Both are Regular Members and can vote and show at all CKCSC-USA events, but only one set of printed publications is mailed to the household.
- 3. All four Regional Clubs welcome new Members from all parts of the country and sponsor Championship Point Shows, Fun Matches, Health Clinics, Eduational seminars and other activities. In addition to the National's *Bulletin*, all four Regional Clubs produce their own informative newsletters that provide additional information on local/regional activities. The only requirement for membership in a Regional Club is membership in the CKCSC-USA.
