1. This completed and signed **APPLICATION TO REGISTER AN INDIVIDUAL DOG FROM A REGISTRY ACCEPTED BY THE CKCSC-USA**.
2. (Optional) **SUPPLEMENTAL SIGNATURE FORM** if dog has more than 2 owners.
3. **CERTIFIED EXPORT PEDIGREE**, or, if not provided by the registering country, **A CERTIFIED 3 GENERATION PEDIGREE**. If this dog is registered with The Kennel Club (of Great Britain), it is necessary to provide a Certified Export Pedigree indicating the colors of all dogs in the pedigree.
4. **REGISTRATION CERTIFICATE** from the registering organization of the dog's country of birth, proving ownership and providing a complete record of official transfers if the dog was not purchased from the litter owner.
5. **CORRECT FEE** (see *Fee Schedule in Bulletin or on Website: www.ckcsc.org*). (Note: All fees doubled for non-members.)

READ BEFORE SENDING:

1. If you plan to register a dog from another registry, you are strongly advised to contact the Registration Office before you acquire the dog, to ensure that the dog you are planning to register was registered at birth with a CKCSC-USA approved registry and to be certain that you will be able to provide all the documents required by the CKCSC-USA for registering such a dog. If the documents are not in order, or if any of the requirements cannot be met, the CKCSC-USA will not register the dog.
2. The responsibility for obtaining all the necessary documents and information in order to register the dog rests with the person(s) acquiring the dog, not with the Registration Office, the Registration Committee or the CKCSC-USA.
3. In no case can a Cavalier born in the United States be registered in a foreign country and subsequently registered with the CKCSC-USA on the basis of its foreign pedigree.
4. Nothing herein shall require the Board of Directors of the CKCSC-USA to consider the addition of any other Registry to the approved list.
5. A CKCSC-USA Certified Pedigree will be issued and mailed to the recorded owner. Upon receipt of the CKCSC-USA Certified Pedigree, the owner should check the pedigree for accuracy and immediately notify the Registration Office if there are any inaccuracies. It is the responsibility of the owner to be sure the pedigree reflects the correct information.
