READ BEFORE SENDING:

1. A Regular Member in good standing, whose affix is registered with the CKCSC, may use this Addition of Registered Affix to Registered Name of Dog form.

(This document will not be processed without authorized signature.)

- 2. The CKCSC-USA allows the addition of only one (1) affix as a suffix to a Cavalier's registered name during its lifetime. Once a suffix has been added to the name of a dog, it may not be removed.
- 3. When an affix is used as a suffix, it must be preceded by the preposition "of" or "at". These prepositions will only be allowed as part of a Cavalier's registered name when used with a suffix. Exceptions may be made if they are used as part of a common phrase, i.e. Tidings Of Great Joy. For example, the puppy you buy is "ASTER Tidings of Great Joy", and you add your affix as a suffix. Its name then becomes either "ASTER Tidings of Great Joy of STONEHENGE" or "ASTER Tidings of Great Joy at STONEHENGE".
- 4. A second suffix is only permitted on a dog whose registered name from an approved registry (other than the CKCSC-USA), prior to being acquired by a resident of the USA, already had one (1) suffix. In the case of a second suffix, "and" will also be allowed between the two (2) suffixes.
- 5. A Cavalier belonging to two (2) people, each with a registered affix, may have the affix of only one (1) of them added as a suffix. To illustrate:
 - a) If "REGIS James" is acquired and co-owned by you and your associate, both of whom have CKCSC-USA registered affixes, either affix, but not both, may be added as a suffix.
 - b) The dog's name would become "REGIS James of ASTER" or "REGIS James of STONEHENGE" but not "REGIS James of ASTER and STONEHENGE".
- 6. Affixes may be added only after the dog has been transferred to the new owner, following the procedures for the TRANSFER OF DOG form.
